Chrome is a set of icons to replace the default application icons in OS X. The icons are organized in five categories. So, once you've made your choice just select the item you want, drag the icon onto the dock and it will be ready to use. The icons are arranged in five categories: Chrome Books, Chrome Macros, Chrome Assistants, Chrome Elements and Chrome Extensions. For example, to replace the Safari icon, you'll drag the icon for Chrome Books onto your dock. Then, you can click the icon and select a replacement. If you wish to see a brief description of each icon you're looking at you can always double click it to see a brief description that provides information about that particular icon. All you need to do is select an icon, right click it and select 'Open In Finder'. This will open the icon in your Finder. Once you see the item in your Finder you can add it to your dock or just click it to launch the app. To edit an icon you'll need to open it in the Finder. You can either just drag the icon from the Finder onto your dock or you can right click it and select the 'Open in Finder' option to open it in the Finder. Once you've open the icon you can select the icon in your Finder and use the 'Resize' option to make changes. You can then drag the icon back to the dock and it will be ready to use. You can also add your own custom icons. If you open an icon in the Finder you'll see an option in the menu for 'Create Symbol' which will create a new icon that will appear in the dock. GNOME Shell 3.16 introduces several new system icons and many new applications. These icons were designed to meet the high quality standards you expect from an icon set. The court unanimously held that (1) the Georgia RICO statute, O.C.G.A. § 16-14-3, which provides that "[a]ll of the provisions of the laws of this state relating to civil conspiracy shall apply to the provisions of this Code," renders inapplicable the statute of limitations contained in O.C.G.A. § 9-3-33, (2) Georgia's RICO statute creates a private right of action for civil damages under that statute, and (3) federal law does not preclude or limit the imposition of treble damages under that statute. Mote, along with U.S. Circuit Judges David T. Nelson, William H. Pryor Jr., and Steven Colloton, dissented in part and concurred in part. Mote argued that the panel had improperly concluded that RICO created a private right of action for damages; he argued that the statute's only remedies were criminal sanctions and injunctive relief. Mote dissented from the majority's refusal to apply the borrowing statute. In the rehearing en banc of In re Lorain Lines, Inc., oral argument was heard on December 11, 2002. The en banc court agreed with the circuit court and the district court that the limitation period set out in O.C.G.A. § 9-3-33 did not apply to RICO, and that civil remedies were available. The United States Supreme Court heard oral argument on February 21, 2003, and on June 27, 2003, the Supreme Court handed down a 4–1 ruling upholding the appellate court's ruling that RICO does not create a private cause of action. The Court did not address the question of when the claim accrued. The Georgia Supreme Court, on its own motion, extended the time for petition for rehearing to July 30, 2003.
